NOTICE TO THE DEFENDANT

1. This paper charges you with committing a crime.
2. If you have been arrested, you have the right to have a judicial officer decide whether you should be released from jail until trial.
3. You have the right to have a lawyer.
4. A lawyer can be helpful to you by:
 - (A) explaining the charges in this paper;
 - (B) telling you the possible penalties;
 - (C) helping you at trial;
 - (D) helping you protect your constitutional rights; and
 - (E) helping you get a fair penalty if convicted.
5. Even if you plan to plead guilty, a lawyer can be helpful.
6. If you want a lawyer but do not have the money to hire one, the Public Defender may provide a lawyer for you. The court clerk will tell you how to contact the Public Defender.
7. If you want a lawyer but you cannot get one and the Public Defender will not provide one for you, contact the court clerk as soon as possible.
8. **DO NOT WAIT UNTIL THE DATE OF YOUR TRIAL TO GET A LAWYER.** If you do not have a lawyer before the trial date, you may have to go to trial without one.

INDICTMENT

****PERJURY/AFFID REQD BY LAW****

The Jurors of the State of Maryland for the body of the City of Baltimore, do on their oath present that the aforesaid IVAN GONZALEZ, late of said City, heretofore on or about **January 24, 2020**, at **417 E. Fayette Street, Benton Office Building, Room 219, Baltimore MD 21202**, did, in an affidavit required by law to be taken, to wit: Certificate of Candidacy form required by Election Law Article §5-301 through §5-303, willfully and falsely make an affirmation certifying residency in Baltimore City under penalties of perjury, when in fact he lived in Baltimore County, the matters so sworn being material, in violation of Criminal Law Article, Section 9-101(a) of the Annotated Code of Maryland; against the peace, government and dignity of the State.

SECOND COUNT

****FALSIFY VOTER REGISTRATION****

The Jurors of the State of Maryland for the body of the City of Baltimore, do on their oath present that the aforesaid IVAN GONZALEZ, late of said City, heretofore on or about **January 24, 2020**, at **417 E. Fayette Street, Benton Office Building, Room 219, Baltimore MD 21202**, did willfully and knowingly violate Election Law Article §16-101 (a)(3) of the Annotated Code of Maryland by falsifying his residence in an attempt to register to vote in the wrong location, to wit: certifying that his residence was in Baltimore City when in fact it was in Baltimore County; against the peace, government and dignity of the State.

THIRD COUNT

****FALSE OATH OR AFFIRMATION****

The Jurors of the State of Maryland for the body of the City of Baltimore, do on their oath present that the aforesaid IVAN GONZALEZ, late of said City, heretofore on or about **January 24, 2020**, at **417 E. Fayette Street, Benton Office Building, Room 219, Baltimore MD 21202**, did willfully and falsely take an affirmation pursuant to the Election Law Article, to wit: falsely certified residency in Baltimore City on the Certificate of Candidacy form required to be filed under oath pursuant to Election Law §5-302, when in fact he lived in Baltimore County, in violation of Election Law Article, §16-501 (a) of the Annotated Code of Maryland; against the peace, government and dignity of the State.

****FALSE ENTRY IN PUBLIC RECORDS****

Fayette Street, Benton Office Building, Room 219, Baltimore MD 21202**, did willfully and falsely make a false entry in a public record to wit: falsely certifying residency in Baltimore City on the Certificate of Candidacy form, when in fact he lived in Baltimore County, in violation of Criminal Law Article, Section 8-606 (b) of the Annotated Code of Maryland; against the peace, government and dignity of the State.
