**CRIMINAL INFORMATION**

THE STATE PROSECUTOR for the State of Maryland, informs and charges, ANDREW BRADSHAW with having committed the following offenses in Dorchester County, Maryland.

**I. INTRODUCTION AND BACKGROUND**

At all times relevant to this Information:

1. The City of Cambridge is an incorporated municipality situated in Dorchester County, Maryland.
2. Andrew Bradshaw (“BRADSHAW”), born in 1989, is the elected Mayor of the City of Cambridge.
3. Reddit.com (“REDDIT”) is an online forum where people can create communities (known as “subreddits”) to communicate. Each subreddit has its own page, subject matter, users, and volunteer moderators (also known as “mods”). Users can share content by publishing stories, links, and/or media (called “posts”) to a subreddit, and other users can comment on those posts. Users can also “upvote” or “downvote” comments and/or posts. The number of upvotes and downvotes a post receives helps determine its position within the subreddit.
4. On or about May 14, 2021, law enforcement was contacted by a female complainant born in 1995 (“VICTIM-1”). VICTIM-1 advised law enforcement that she discovered nude photographs of herself posted to the public website REDDIT.

5. VICTIM-1 advised law enforcement that she was outside of the State of Maryland when she learned that her nude photographs were posted to REDDIT.
6. VICTIM-1 advised law enforcement that the photographs were posted without her knowledge or consent.
7. VICTIM-1 advised that she transmitted the posted photographs only to one other person, Andrew BRADSHAW, that the photographs were sent when she and BRADSHAW were in an intimate relationship, and that she did not provide BRADSHAW with consent to re-distribute the photographs.
8. VICTIM-1 advised law enforcement that she is no longer romantically involved with BRADSHAW.
9. Accounts associated with VICTIM-1's picture ("TARGET REDDIT ACCOUNTS") were utilized to post photographs of VICTIM-1's face and intimate parts to public REDDIT forums. Each of these accounts has a public username consisting of permutations of VICTIM-1's legal name and/or date of birth.
10. Some REDDIT forums where the photographs of VICTIM-1 include subreddits named "HumiliatingComments", "DegradeThisPig", "DegradedCaptions", "Slut", and "needysluts". Additional photographs of VICTIM-1 were posted in subreddits specifically related to "raceplay" with racial slurs in several of the posting titles.
11. The TARGET REDDIT ACCOUNTS were utilized to post photographs of VICTIM-1's face and intimate parts from internet protocol ("IP") address 69.251.0.252 ("IP ADDRESS"). This IP ADDRESS, at the dates and times of the activity cited herein, provided internet service to 115 Glenburn Avenue, Cambridge, MD 21613.

12. Maryland Department of Taxation and Assessment records show that 115 Glenburn Avenue, Cambridge, MD 21613 is owned by BRADSHAW.

**II. RACEPLAY SUBREDDIT POSTS**

**COUNT 1 – DISTRIBUTE INTIMATE SEX IMAGE**

On or about May 20, 2021, at Dorchester County, Maryland, ANDREW BRADSHAW, did knowingly distribute a visual representation (with caption “Fucked a [redacted] for the 1st time last night- I'm still smiling this morning from the orgasms he gave me”) of Victim 1, that displays said person’s intimate parts exposed, with the intent to harm said person, with reckless disregard as to whether said person consented to the distribution and under circumstances in which the other person had a reasonable expectation that the image would remain private, in violation of §3-809 of the Criminal Law Article and against the peace, government and dignity of the State.

**COUNT 2- DISTRIBUTE INTIMATE SEX IMAGE**

On or about May 20, 2021, at Dorchester County, Maryland, ANDREW BRADSHAW, did knowingly distribute a visual representation (with caption “The kind of white girl [redacted] love to nut on”) of Victim 1, that displays said person’s intimate parts exposed, with the intent to harm said person, with reckless disregard as to whether said person consented to the distribution and under circumstances in which the other person had a reasonable expectation that the image would remain private, in violation of §3-809 of the Criminal Law Article and against the peace, government and dignity of the State.

On or about May 3, 2021, at Dorchester County, Maryland, ANDREW BRADSHAW, did knowingly distribute a visual representation (with caption “Ready to try my first ever [redacted] dick”) of Victim 1, that displays said person’s intimate parts exposed, with the intent to harm said person, with reckless disregard as to whether said person consented to the distribution and under circumstances in which the other person had a reasonable expectation that the image would remain private, in violation of §3-809 of the Criminal Law Article and against the peace, government and dignity of the State.

On or about May 3, 2021, at Dorchester County, Maryland, ANDREW BRADSHAW, did knowingly distribute a visual representation (with caption “Ready to try [redacted] dick for the 1st time”) of Victim 1, that displays said person’s intimate parts exposed, with the intent to harm said person, with reckless disregard as to whether said person consented to the distribution and under circumstances in which the other person had a reasonable expectation that the image would remain private, in violation of §3-809 of the Criminal Law Article and against the peace, government and dignity of the State.

cock”) of Victim 1, that displays said person’s intimate parts exposed, with the intent to harm said person, with reckless disregard as to whether said person consented to the distribution and under circumstances in which the other person had a reasonable expectation that the image would remain private, in violation of §3-809 of the Criminal Law Article and against the peace, government and dignity of the State.

expectation that the image would remain private, in violation of §3-809 of the Criminal Law Article and against the peace, government and dignity of the State.

violation of §3-809 of the Criminal Law Article and against the peace, government and dignity of the State.

TO THE PERSON CHARGED:

1. This paper charges you with committing a crime.
2. If you have been arrested and remain in custody, you have the right to have a judicial officer decide whether you should be released from jail until your trial.
3. If you have been served with a citation or summons directing you to appear before a judicial officer for a preliminary inquiry at a date and time designated or within five days of service if no time is designated, a judicial officer will advise you of your rights, the charges against you, and penalties. The preliminary inquiry will be cancelled if a lawyer has entered an appearance to represent you.
4. You have the right to have a lawyer.
5. A lawyer can be helpful to you by:
  - (A) explaining the charges in this paper;
  - (B) telling you the possible penalties;
  - (C) explaining any potential collateral consequences of a conviction, including immigration consequences;
  - (D) helping you at trial;
  - (E) helping you protect your constitutional rights; and
  - (F) helping you to get a fair penalty if convicted.
6. Even if you plan to plead guilty, a lawyer can be helpful.
7. If you are eligible, the Public Defender or a court-appointed attorney will represent you at any initial appearance before a judicial officer and at any proceeding under Rule 4-216.2 to review an order of a District Court commissioner regarding pretrial release. If you want a lawyer for any further proceeding, including trial, but do not have the money to hire one, the Public Defender may provide a lawyer for you. To apply for Public Defender representation, contact a District Court commissioner.
8. If you want a lawyer but you cannot get one and the Public Defender will not provide one for you, contact the court clerk as soon as possible.
9. **DO NOT WAIT UNTIL THE DATE OF YOUR TRIAL TO GET A LAWYER.** If you do not have a lawyer before the trial date, you may have to go to trial without one.
