Main Purpose Of Job

This position conducts investigations of financial crimes and provides forensic accounting and audit support to inquiries regarding violations of Maryland law for the Office of the State Prosecutor. Position reports directly to the Chief Investigator. This position provides expertise and support to other investigators regarding financial crimes and fiscal matters, including fraud, theft, embezzlement, and campaign finance law violations.

POSITION DUTIES

Responsibilities will include the collection, review and analysis of financial and business records, social media, and other documents, interviewing potential witnesses, victims and suspects; collecting, preserving, and analyzing other physical and documentary evidence; preparing and participating in the execution of search warrants and other legal process; preparing concise reports and detailed documentation of investigative efforts; assisting prosecutors with trial preparation; and testifying in grand jury proceedings, criminal trials, and other hearings.
