## **CRIMINAL INFORMATION**

THE STATE PROSECUTOR for the State of Maryland, informs and charges, FRANCIS G. BAGNALL with having committed the following offenses:

## <u>COUNT 1</u> (Fraudulent Voting)

On or about November 6, 2018, in Baltimore County, Maryland, the Defendant, FRANCIS G. BANGALL, did willfully, knowingly, and unlawfully vote in an election district and/or precinct in the 2018 Maryland Gubernatorial General Election without having the legal authority to vote therein, to wit: upon signing the voter authority card under the name "Francis Bagnall" the Defendant, who is not a citizen of the United States, did cast a ballot without having a lawful right to do so, in violation of Election Law Article, Section 16-201 of the Annotated Code of Maryland, and against the peace, government, and dignity of the State.

Voting Without Legal Authority Election Law Article, Section 16-201(4) Penalty: 5 years and/or \$5,000 dollars CJIS code 1-1501

### <u>COUNT 2</u> (False Voter Registration)

On or about March 18, 1996, FRANCIS G. BAGNALL, did willfully, knowingly, and unlawfully misrepresent his citizenship status on a voter registration application, to wit: for the purpose of establishing eligibility to vote and registering as a qualified voter, the Defendant under the name "Francis Bagnall" provided materially false information as to his voter qualifications and did fraudulently swear or affirm that he was a United States citizen, in violation of Election Law Article, Section 16-101 of the Annotated Code of Maryland, and against the peace, government, and dignity of the State.

False Voter Registration Election Law Article, Section 16-101(8) Penalty: 5 years and/or \$1,000 dollar fine CJIS Code 2-0372
