On May 12, 2023, Mr. Bagnall admitted that he was not a citizen of the United States and identified the signature on this Voter Authorization card as his signature, confirming that he voted in the 2018 Gubernatorial General Election.

Mr. Bagnall responded to a jury summons from Baltimore County where he indicated he was not a citizen of the United States.

If called to testify, witnesses would identify Mr. Bagnall as the individual who voted in the 2018 Gubernatorial General Election. Mr. Bagnall willfully and knowingly voted, without the legal authority to vote and not a citizen of the United States. All events occurred in Baltimore County, Maryland.
