## **INDICTMENT**

THE GRAND JURY, for the State of Maryland, sitting in Frederick County, upon their oath and affirmation, present the following:

## COUNT 1—EMBEZZLEMENT—MISAPPROPRIATION BY FIDUCIARY

1. From in or about December 2021, through and including March 2023, in Frederick County, Maryland, MICHAEL PERRY, being a fiduciary of the business known as GROUNDSWELL MMA LLC [hereinafter, "GROUNDSWELL"], did fraudulently and willfully appropriate to a use contrary to his trust, money held by him in his fiduciary capacity, to wit: PERRY, being a Member of GROUNDSWELL and having a duty to ensure that contributions, expenditures, and loans were made in accordance with the terms of the Operating Agreement, made payments to himself personally or for his personal use and benefit in the amount of approximately \$66,904.93, in violation of Criminal Law Article, §7-113 of the *Annotated Code of Maryland*, and against the peace, government, and dignity of the State.

Penalty: Not less than 1 year and not exceeding 5 years

## COUNT 2—THEFT SCHEME

Withdrawals/Transfers—\$25,000 to \$100,000

2. From in or about December 2021, through and including March, 2023, in Frederick County,

Maryland, MICHAEL PERRY did, pursuant to one scheme and continuing course of conduct,

steal from GROUNDSWELL, for his personal use and benefit, monies, credit, or funds having a

value of at least \$25,000 but less than \$100,000, in violation of Criminal Law Article, §7-104 of

the Annotated Code of Maryland and against the peace, government, and dignity of the state.

**COUNT 3—THEFT** 

BMW Down Payment—\$1,500 to \$25,000

3. On or about July 28, 2022, in Frederick County, Maryland, MICHAEL PERRY did steal

from GROUNDSWELL for his personal use and benefit, monies, credits, or funds having a value

of at least \$1,500 but less than \$25,000, in violation of Criminal Law Article, §7-104 of the

Annotated Code of Maryland and against the peace, government, and dignity of the state.

COUNT 4—IDENTITY FRAUD (ASSUMING IDENTITY OF ANOTHER)

American Express—\$1,500 to \$25,000

4. In or around July 2022, in Frederick County, Maryland, MICHAEL PERRY possessed

personal identifying information of Z.D., without the consent of Z.D., for the purpose of using that

information to obtain a benefit, to wit: PERRY used Z.D's social security number without his

consent, representing that he was Z.D. to obtain credit from American Express, having a value of

at least \$1,500 but less than \$25,000, in violation of Criminal Law Article §8-301 of the Annotated

Code of Maryland, and against the peace, government, and dignity of the State.

COUNT 5—IDENTITY FRAUD (ASSUMING IDENTITY OF ANOTHER)

Fundbox Inc. (\$39,000)—\$25,000 to \$100,000

5. In or around May 2022, in Frederick County, Maryland, MICHAEL PERRY did knowingly,

willfully, and with fraudulent intent possess personal identifying information of Z.D., without the

consent of Z.D., for the purpose of using that information to obtain a benefit, to wit: PERRY used

Z.D.'s social security number without his consent, signed the Term Loan Personal Guarantee on

behalf of Z.D., representing that he was Z.D., to obtain financing from Fundbox Inc., having a

value of \$39,000, in violation of Criminal Law Article §8-301 of the Annotated Code of Maryland,

and against the peace, government, and dignity of the State.

**COUNT 6—IDENTITY FRAUD (ASSUMING IDENTITY OF ANOTHER)** 

CFG Merchant Solutions (\$12,000)—\$1,500 to \$25,000

6. In or around August 2022, in Frederick County, Maryland, MICHAEL PERRY did

knowingly, willfully, and fraudulently possess personal identifying information of Z.D., without

the consent of Z.D., for the purpose of using that information to obtain a benefit, to wit: **PERRY** 

used Z.D.'s social security number without his consent, signed on behalf of Z.D., representing that

he was Z.D., to obtain financing from CFG Merchant Solutions, having a value of \$12,000 in

violation of Criminal Law Article §8-301 of the Annotated Code of Maryland, and against the

peace, government, and dignity of the State.

COUNT 7—IDENTITY FRAUD (ASSUMING IDENTITY OF ANOTHER)

Fundamental Capital (\$21,340)—\$1,500 to \$25,000

7. In or around October of 2022, in Frederick County, Maryland MICHAEL PERRY did

knowingly, willfully, and fraudulently possess personal identifying information of Z.D., without

the consent of Z.D., for the purpose of using that information to obtain a benefit, to wit: PERRY

used Z.D.'s social security number without his consent, signed on behalf of Z.D., representing that

he was Z.D., and pretended to be Z.D. in a telephone conversation, to obtain financing from

Fundamental Capital, having a value of \$21,340 in violation of Criminal Law Article §8-301 of

the Annotated Code of Maryland, and against the peace, government, and dignity of the State.

COUNT 8—WILLFUL FAILURE TO FILE TAX RETURN

8. On or about April 18, 2023, in Frederick County, Maryland, and elsewhere, MICHAEL

PERRY did willfully fail to file a Maryland income tax return as required by law, in violation of

Tax - General Article § 13-1001(d) if the Maryland Code against the peace, government, and

dignity of the state.
